Center receives national research fellowship

The Coalition of Urban and Metropolitan Universities (CUMU) awarded a research fellowship to our center this spring - it's the first time the coalition has named a research center as a fellow.

CUMU is known as the longest-running and largest organization committed to serving and connecting the world's urban and metropolitan universities and their partners. The research fellowship includes six months of collaboration with the coalition, designing and leading CUMU's 2021 Summer Action Summit on addressing housing insecurity and homelessness, identification of research projects and securing support for projects identified.

"This partnership will help us collaborate with universities and researchers around the country to identify how we can better address homelessness, particularly for people of color," said center Director Dr. Marisa Zapata.

Bills on homelessness move

through legislature

The center is tracking about 50 bills that relate to homelessness in the Oregon State Legislature this session, including at least one that has passed: <u>HB 2006</u> (siting of emergency shelters) and another that looks likely to pass, HB 3115 (provides protection against sit/lie

We're fans of the Mobile Housing Team

The Mobile Housing Team helps approximately 200 families a year exit homelessness into housing thanks to wrap-around supports. It's the type of program slated to expand services to help even more residents exit homelessness through the voter-approved supportive services



measure. <u>JOIN</u> is the lead agency coordinating the team that includes <u>Portland Homeless Family</u> <u>Solutions</u>, <u>Immigrant and Refugee Community Organization</u>, <u>Native American Youth and Family</u> Association, Native American Rehabilitation Association, El Programa Hispano Católico, Latino Network, and Self Enhancement, Inc.

One family's story

Five insights on homelessness around the US

- Hotel shelter programs have had a positive impact on participant health and wellbeing. Municipalities across the country are beginning to acquire hotels and motels to serve as long term affordable housing, often using a combination of federal, state, and local funds.
- Housed and unhoused Oaklanders created <u>a collection of small cob structures</u> featuring a kitchen, shower and health clinic on publicly-owned CalTrans land. Organizers did not receive approval to use the land, but CalTrans has no immediate plans to remove it.
- Washington became the first state in the nation to pass a civil <u>Right to Counsel</u>, which provides free legal assistance to all low-income tenants facing eviction. The state joins several cities that have already implemented the policy, including New York City and San Francisco.
- 4. **The Private Equity Stakeholder Project** released <u>a report</u> on how one of America's major corporate landlords has filed to evict more than 1,300 residents during the pandemic.
- 5. <u>A new study</u> looks at the connection between evictions and health-related behaviors.

Bonus: Shelterforce explores the <u>history of HUD's tenant organizing fund</u> (514 funding) and why it has barely been used in two decades, with the hope that the Biden administration will reactivate it.
