## Port of San Diego Selects EDF Renewables North America for Microgrid Installation

EDF Renewables North America (EDFR) announced on Dec. 7 the awarding of a contract to build a 700 kW / 2,400 kWh Microgrid Infrastructure Project for the Port of San Diego.

The Microgrid Infrastructure Project, consisting of a battery storage system and electrical infrastructure projects \$3.2 million in energy savings for the Port during regular operations over 20 years, and aligns with California Government Code 4217 providing the best value to the Port. The system will provide

emergency back-up power to the Port-operated facilities, including security infrastructure, lights, offices, and existing jet fuel storage system in support of the Port's role as a Strategic Port.

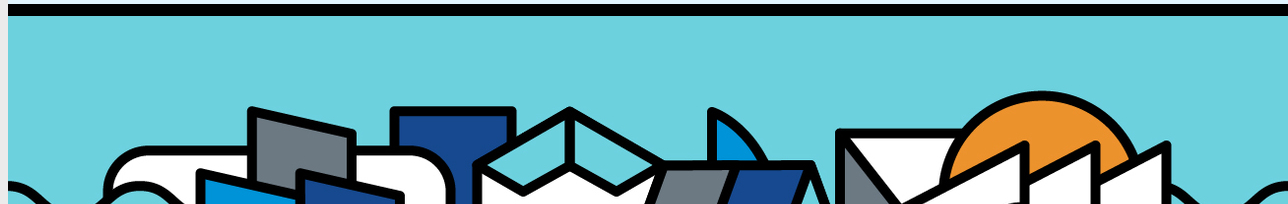
