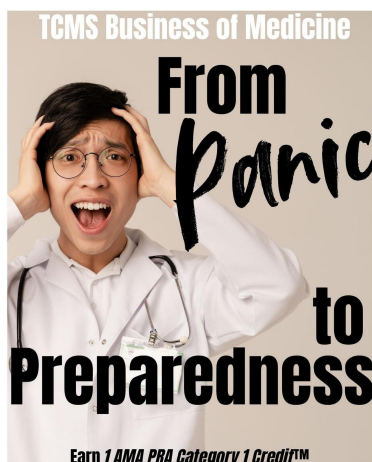

Modifier 25 Services Slashed in 2027 Medicare Fee Schedule Proposal

TMA is reviewing the proposed 2027 Medicare Physician Fee Schedule and preparing formal comments to the Centers for Medicare & Medicaid Services (CMS), with particular concern about the proposed changes to Modifier 25. These changes could have dramatic negative impact on physician payments. TMA urges you to submit comments to CMS by the September 14, 2026 deadline (referencing **CMS-1848-P**) and to include personal examples of how the proposal would affect your practices and patient care.
