### Modernizing AWG Monitoring

For 2019, Alpine Watershed Group is making some exciting updates to its ambient water quality monitoring program. AWG is updating its monitoring equipment, replacing older, outdated meters and titration kits with brand new YSI meters that will allow us to collect our



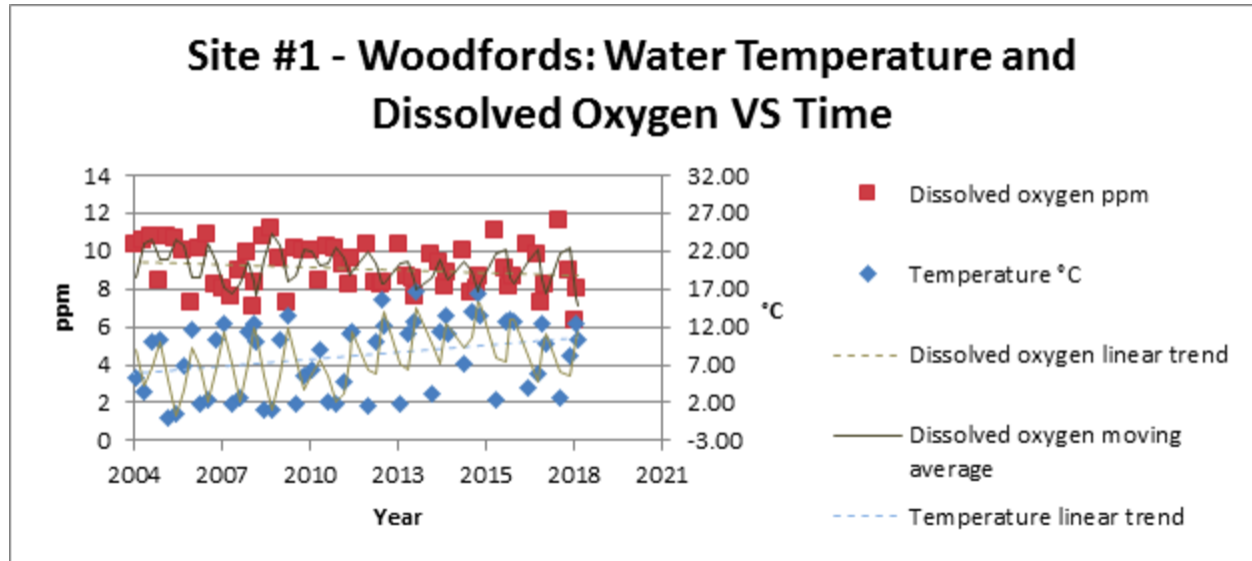
ambient data more efficiently with greater accuracy and precision. With this update will come a slight change to the structure of our volunteer monitoring days. Stay tuned, river monitors! In May, AWG will host a combined volunteer training day and intercalibration day, during which we will train volunteers on using the new equipment and work with other organizations to test the accuracy and precision of our instruments. The first round of river monitoring takes place March 7-9. The anticipated 2019 river monitoring dates include: June 6-8, August 8-10, and September 12-14. ### What Can We Do with Monitoring Data?

Right after starting his AmeriCorps term last fall, Restoration and Monitoring Coordinator Taylor Norton took a crack at doing some in-depth analysis on AWG's 14 years of ambient water quality data. Taylor examined trends in dissolved oxygen at each of our sampling sites and found some interesting patterns. Our data suggests that over the past 14
