January winter weather by the numbers:

- 31,000miles driven by snow plow drivers
- 1,400 tons of salt laid on roads
- <u>4 blown transformers</u> replaced
- <u>12,000 gallons</u> of liquid brine used
- 9 broken power poles replaced

Case against City of Independence, IPL ends, no evidence IPL overcharged customers

The Missouri Court of Appeals has issued a decision in the 2018 class action lawsuit against the City of Independence and Independence Power & Light. The Court found there was no evidence to suggest the City of Independence or IPL overcharged customers or violated the City Charter.

The class action lawsuit, filed by the Accurso Law Firm on behalf of customers, claimed the City of Independence and IPL did not bill customers correctly for electricity in 2018 after transitioning to a new payment software

and therefore overcharged them. The suit also claimed that various city officials had not complied with the City Charter in their operation of IPL.

The Circuit Court of Jackson County rules against all of the claims in August of 2022. The Plantiffs appealed that decision. On December 26th, the Missouri Court of Appeals, Western District, denied the Plaintiffs final appeal -- effectively ending the case.

IPL Director retires

Independence Power & Light Director James Nail retired earlier this month. He served the City of Independence for nearly 20 years.

Nail first joined the City in 2004 and worked in various roles in the department until accepting the position of Director in 2020.

Joseph Hegendeffer, previously the department's Deputy Director, has succeed Nail and has already begun serving in the role.

Employee spotlight

This month, we want to spotlight all of our **Streets Operations team** from our Municipal Services Division.

In 2023, our Street Operations team paved the way to a better, cleaner, and safer road network -- and the results are in! Last year, our crews repaired a total of 9,060 potholes (183 per week), swept 519 miles of streets, replaced/repaired 1,052 traffic signs and laid down 22 miles of crack seal.
