Legislators will spend the first couple of weeks dealing with committee appointments, office assignments, and establishing rules on bill sponsorship.

On January 8, TN Legislators begin filing their bills...and that's when TN Catholic Public Policy Commission (TNCPPC) kicks it in gear:

TNCPPC Committees and Bishops will already be reviewing AND tracking bills that impact social justice issues and the common good of all TN citizens—especially the vulnerable.

TNCPPC will be meeting with the new Legislators to present the Church's position on these bills.

Up to now, legislation for **Better School Choices for Parents** has been held up in the **TN House of Representatives**. The Senate has passed this legislation multiple times. The House, however, not so much.

We have new Legislators in place. NOW would be a great time to reach out to your Representative and advocate for Better School Choices for Parents.

HealthCare

Aches and Pains | **We must expand Medicaid.**

Doing so will

- help cover 300,000 uninsured Tennesseans,
- lower health insurance premiums,
- provide greater access to addiction treatment centers,
- help sustain TN rural hospitals. **We have already lost 9:** Copper Basin Medical Center, Copperhill; Gibson General Hospital, Trenton; Haywood Park Community Hospital, Brownsville; Humboldt General Hospital; Parkridge West Hospital, Jasper; Starr Regional Medical Center, Etowah; McKenzie Regional Hospital; McNairy Regional Hospital, Selmer; and United Regional Medical Center, Manchester.

Reach out to your Legislator today—especially if they're new to Capitol Hill—and advocate for the expansion of Medicaid.
