Decades of Medicare pay cuts are negatively impacting physician practice viability. This diminishes access to care for ALL patients.

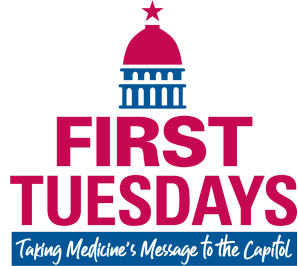
We must ensure our seniors are cared for with the highest standard of care. We must develop a permanent, viable Medicare physician payment system.


