## >> October General Membership Meeting Report and Election Results

### **Election Results:**

The Slate of Candidates offered by the Nominating Committee was unanimously elected: Karen Cordry, President; Erl Houston, Vice-President; Ann Arevalo, Secretary; and Jim Ryan, Treasurer -- with a quorum including the online votes. Thanks to all! We look forward to serving for the next two years and intend to keep our outgoing officers, Mark Meszaros, Vice President, and Wendy Core, Secretary, involved. We say goodbye to them with a hearty thanks for their service the last four years.

### **Expanding KHCA and Changes to Bylaws:**

There was also a unanimous vote to add the additional homes to the east of our current boundaries, bringing KHCA to the edge of Georgia Avenue. As a result, we are now almost 1,000 homes strong. We welcome our new members and will be doing some more outreach activities in current months to make sure we are staying in touch with you. The last vote was on changing the bylaws which again passed with no dissenting votes. The main changes are you will no longer need to sign up every two years to be an "Active Member," but there will be a dues obligation in order to be a voting member on issues that come before KHCA. Dues will be paid on a calendar year basis and will be \$10 a person up to a maximum of \$30 per household. Please contact KHCA President Karen Cordry if you have questions.

### **Special Discussions:**

Our feature presentation was by Ivan Eloisa, Manager at the Code Enforcement section of the Department of Housing and Community Affairs, and Sgt. David Reed from the Fourth District. They both spoke on available resources for dealing with "problem houses" in the neighborhood. Mr. Eloisa noted that the initial step to making a complaint is to either contact the county's call center by dialing 311 or by going to the DHCA website. You can request that your information be kept confidential. After that, a case will be opened and assigned to an investigator who will determine if there is a violation. If so, a notice of violation will be sent to the homeowner with a deadline to comply (generally 30 days for non-emergency violations and 24 hours for emergency issues.) The County also has the right to do the work itself and charge the property owner for the costs. More info. A short guide to Code enforcement is also available. Sgt. Reed also referred people with complaints about matters that might fall into police jurisdiction to either the non-emergency number – 240-773-5500 – or 911 for emergencies. He noted some of the resource constraints that might slow down a response and also had some practical suggestions about trying to deal with your neighbor before going to the police (such as asking an apartment or HOA official to intervene first.) He also urged neighbors to be alert to situations with vacant houses to ensure that they were not being broken into and used by homeless people, or those using them to carry out illegal activities. If you see or suspect something, the police ask that you let them know and they will follow up.

We also invited Kensington Nursing Home representatives to meet with us. There was a great discussion and we hope to continue to collaborate with them. (One thing that we can report on is that the “pond” is looking much better. They have been working with the County to use environmentally appropriate methods to get rid of the green “goop” that has been covering the surface so that they can start the fountains back up again. As of now, things are *much* improved!)

Additionally, we had a brief report from our Beautification Committee Chair about several County programs including their **free** shade tree program and their “rainscapes” program. You can apply for free trees. These are large trees (6-10 feet tall) and the county plants them for you. You can’t get a better deal although there is a bit of a wait time (often a year or more), so get your name in now to get in line. The rainscapes program deals with a wide variety of water conservation measures, ranging from rain barrels to pervious pavements to rain gardens. The county provides a great deal of technical assistance – and, best of all, reimburses part of your costs. KHCA President Karen Cordry recently used this program to replace a section of her shady backyard that had turned to nothing but moss into a swath of native plants that will hopefully both beautify that section and soak up rain running down the slope from her house. We expect to use the first meeting next year in early spring to have a detailed presentation on these programs and other proposals for KHCA beautification projects. Stay tuned!
