Special Issue: Reflections on the Role of
Antitrust Law in an Era of Corporate Medicine
and Deregulation - Looking Back and
Squinting Forward

Abstracts due July 15, 2025

As the Trump Administration rolls out a push toward deregulation in healthcare and elsewhere, this themed issue of the Saint Louis University Journal of Health Law and Policy brings together leading antitrust and competition scholars to examine the role—past, present, and future—that antitrust law can and should play in healthcare. The journal seeks articles that address any or all of the key concerns in healthcare delivery—access, quality, cost, and equity—focusing on how antitrust and competition law have succeeded or failed in the past and might change the future trajectory of healthcare, especially in this time of corporate medicine and deregulation.

Thomas “Tim” Greaney (Chester A. Myers Professor of Law Emeritus, Saint Louis University School of Law; Research Professor, University of California College of the Law San Francisco) will provide the keynote article entitled "Antitrust and Health Care: A Tangled Web." Other authors for the issue include **Michael Carrier (Board of Governors Professor of Law, Rutgers Law School)**, **Jaime King (Dean of Law, University of Auckland, New Zealand Law School)**, and **Barak Richman (Alexander Hamilton Professor of Business Law, George Washington University Law School)**.

The SLU Journal of Health Law and Policy is interdisciplinary, and we welcome single- and co-authored submissions from health law and policy, bioethics, critical legal theories, public health, ethics and other disciplines. Submissions can be empirical, descriptive, or analytical, as long as they relate to or shed light on the broad questions raised in this special issue. Length of submissions may vary. Legal pieces should be thesis-driven and typically range from 5,000-8,500 words (12-20 journal pages) for shorter pieces to 10,000-20,000 words (25-45 journal pages). We also welcome interdisciplinary pieces of varying lengths.

Abstracts of 250 words or less are due by Tuesday, July 15. Completed papers are due Monday, December 15.

We will host a Zoom works-in-progress session to allow authors to share ideas,

outlines, and early drafts in early October.
