MESSAGES TO AMPLIFY

Course Materials Reporting: The deadline has passed for reporting course materials through the DuckStore. You will be receiving an email with a list of courses in your area that have not yet reported. Please help us by [sharing these reporting instructions](#) to instructors in your area who have not yet reported. It is very important that we have complete reporting for all courses, *even if they have no required course materials*, to comply with state legislation.

FINAL YEAR! Core Education Course Reapproval: This is the last year to [submit Core Education courses for reapproval](#) through the expedited summer process. You will receive a list of courses that have yet to be approved. In order to retain Core Education status, these courses need to be submitted for reapproval by June 9, 2023. If you'd like support during the proposal development process, please contact [Ron Bramhall](#) or [Lee Rumbarger](#) – we are available to attend faculty meetings and workshop with you.
