

# Wisconsin Coastal Management Program

The Wisconsin Coastal
Management Program (WCMP) is
offering up to \$1.6 million in grants
aimed at enhancing, preserving,
protecting, and restoring natural
resources along Wisconsin's Great
Lakes coasts, which include nearly
1,000 miles of shoreline across
counties adjacent to Lakes Superior
and Michigan. These grants support
a wide range of projects, from
coastal wetland protection and
habitat restoration to nonpoint
source pollution control and
community planning.

# NOAA Great Lakes Fish Habitat Restoration Partnership Grants

Up to \$12 million in Great Lakes Restoration Initiative funding is available for NOAA Great Lakes Fish Habitat Restoration Partnership Grants. This funding supports habitat restoration projects that provide significant and sustainable benefits for native fish species in the Great Lakes. The Great Lakes face ongoing threats like habitat degradation, pollution, and invasive species. These projects aim to improve fish habitats, supporting fisheries, restoring wetlands, enhancing recreational opportunities, and increasing community resilience.

# 2025 Landscape Scale Restoration (LSR) Grant Program

The purpose of this competitive grant program is to encourage collaborative, science-based restoration of forest landscapes, leverage public and private resources, and support priorities identified in State Forest Action Plans.

Prospective applicants should use the <u>2020 Wisconsin Forest Action</u> <u>Plan</u> to align project proposals with state and regional priorities. #### **Great Lakes Project Coordinator - Trout Unlimited**

The Great Lakes Project Coordinator will support cold water conservation efforts in Northwest Wisconsin's Lake Superior Watershed. Key duties include conducting aquatic organism passage inventories, gathering data for habitat restoration, engaging with partners, and overseeing monitoring at project sites. The role also involves assisting with restoration projects, managing seasonal interns, writing grants, and coordinating with agencies and stakeholders. Lake of the Woods, Minnesota's largest natural Walleye lake, faces significant angling pressure and is an important statewide resource.

#### Grants Manager - Alliance for the Great Lakes


