- Another bill dealing with Prosecution of sex crimes against children | Bill SB0368 / HB0286 | *Representative Jim Coley (R) Bartlett and Senator Becky Massey (R) Knoxville*
- **Both bills** deal with the time of limitations for prosecuting the offender
- The BEST of BOTH BILLS will be combined into ONE by the 4 sponsors from BOTH the Senate and the House—THAT'S WHAT WE LIKE TO SEE!


