### Reflections on ‘Balancing Privacy and Public Health during COVID-19’

On November 11, 2020, [Osgoode Privacy Law Society \(OPLS\)](#), in collaboration with [Osgoode Health Law Association \(OHLA\)](#) and [Osgoode Constitutional Society \(OCLS\)](#), held a panel event to discuss the existing tensions between public health and individuals' privacy rights that have been pushed to the forefront of conversations as a result of the COVID-19 pandemic.
