First quarterly reporting submission is due on **December 31st**.

Information, guidance, and updated templates will be shared soon. Reporting will look very similar to the expenditure reporting procedure in the 2024-25 school year through Metrix.

2026/2027 Program Year

Calendar Submission

Providers will need to submit a Calendar for the 2026-2027 PY.

Program Setup Forms for 2026/2027

The window to submit your forms to participate in the pre-registration phase (Continuity of Care) is now **CLOSED!** You can still submit your form but your programs won't be uploaded until January for the general matching rounds.

Important Timeline Details

Pre-registration will open on December 9th! Families requesting Continuity of Care (CoC) placements, sibling attending, or child of an employee will be matched during this round. Families must complete their CoC registration by **February 2nd 2026**.

The 1st family-to-provider matching round will run on **February 16th 2026**.

The 2nd and final family-to-provider matching round will run on **March 16th 2026**.

Direct Enrollment for the 26-27 PY will begin on **April 1st**.
