Re: 2020 Teacher Trustee Election Reminders

Thank you for serving as your school's Pension Representative.

If you have not already done so, please <u>download and return your credentials</u> <u>form</u> and view a webinar so you can qualify for your stipend. You must complete an attestation form to receive your stipend (see below).

Pension Rep Stipends and Attestation Forms

Pension Reps qualify for a \$100 stipend if they view a webinar and share information with teachers. In order to receive a stipend, you must complete an Attestation Form and return by November 20, 2020, to receive your stipend in December.
