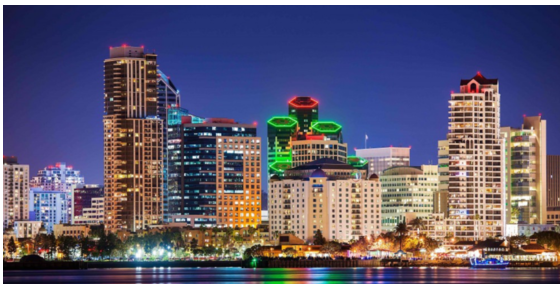

### Large Commercial and Multifamily Building Energy Benchmarking Now Required in City of San Diego - Deadline is Sept 1.

In Feb. 2019, the City of San Diego adopted a Building Energy Benchmarking Ordinance that requires all building owners and managers with commercial and multifamily buildings greater than 50,000 square feet within San Diego City jurisdiction to report their whole-building energy use to the city by June 1, 2020. **Due to COVID-19, the City is allowing building owners to submit energy data until Sept. 1.**

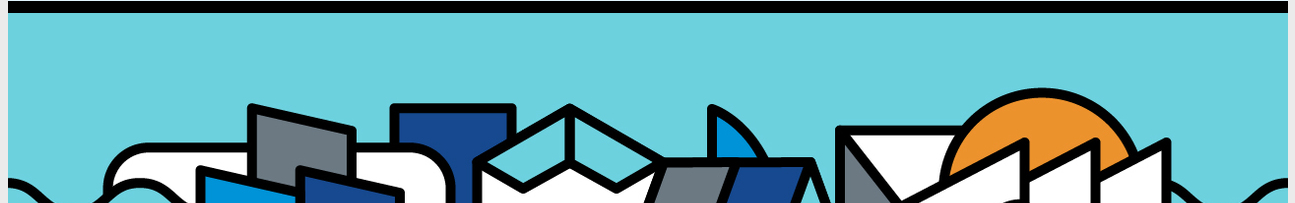
