Cost Transfer Withdraw Issue

We have identified an issue where withdrawn cost transfers are still being processed or completed. It appears to be happening when withdrawn from the Things to Finish > Created by Me list. Oracle is already working on the issue and we will provide more information as soon as it's known.

If you need to withdraw a pending cost transfer, **do not** do so from the Things to Finish list. Instead navigate to Projects & Awards > Costs > Tasklist (paper icon) > Manage Project Costs > search for the transaction number(s) > navigate to the Adjustment History tab and highlight the pending row before selecting "Cancel Adjustment".

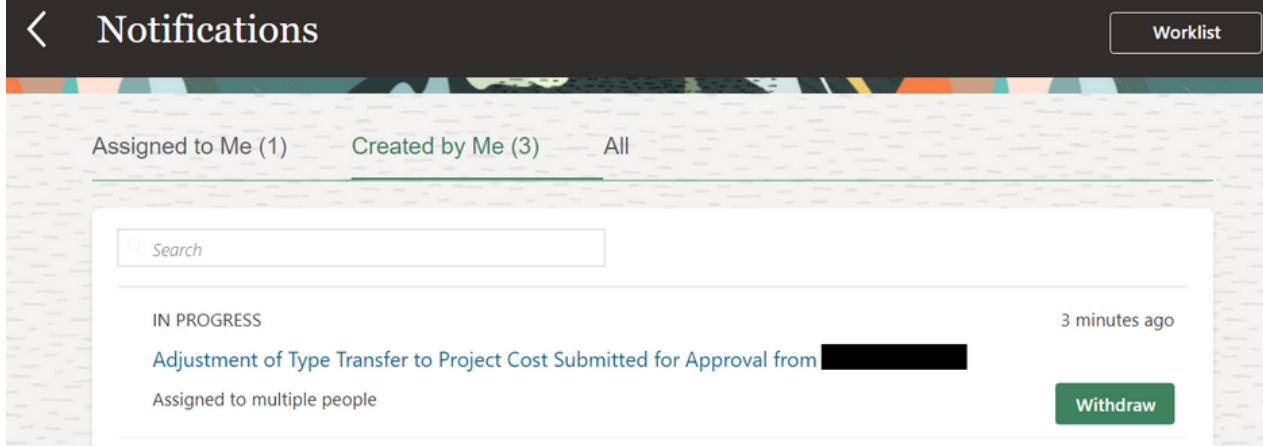

New Interlocation Transfer of Funds (ITF) Form

Going forward, UCOP is requiring all UC Campus' to complete a new ITF template when transferring funds between Campus' or UCOP. A new COA chartstring format will replace the FAU (Full Accounting Unit) that was previously required. Use the following KBAs for guidance:

PADUA Updates: Enhancements

"Reporting Category" is now a required value when creating new projects (ex. Department or Faculty Portfolio). Any updates to existing projects will require this to be updated if they are not already assigned a Reporting Category.

Tasks on General Projects can now be backdated as needed/appropriate.

New Contract with Hertz!

After more than 15 years, University of California has a new contract with Hertz that went into effect on July 1, 2023.

While our UC rates are still incredibly competitive, the daily rate will increase by an average of \$2 and all reservations made prior July 1 have been notified by Hertz of the new rates. This change will be more noticeable by those who have confirmed larger vehicles such as minivans/SUVs or specialty/premium cars.

What hasn't changed:

- Unlimited mileage within California (and now New Jersey as well)
- One-way rentals within California for no drop-off fees

While UC faculty and staff can use the contracted rates for personal travel, the insurance will not apply. As a result, reservations for personal rentals must be made using specific links in the [Connexus portal](#) instead of through Concur or Balboa Travel.

Streamlining Your Campus Event and Entertainment Expenses

As we embrace the vibrant energy of the fall quarter, our campus events and entertainment scene is buzzing with activity. The Central Office is here to offer some helpful reminders that will simplify the process of reconciling your event expenses within Concur:

1. **Method of Payment:** We strongly recommend using your Travel and Entertainment (T&E) Card for all event and entertainment expenses to eliminate any out-of-pocket expenditures.
2. **Timing Matters:** If you use your T&E Card to make a deposit for an event, it's essential to wait until the event has concluded before reconciling the card charges in a single expense report. This step is critical to ensure that your reports comply with the BUS-79 Entertainment Policy's meal maximums, which may require additional approvals. Combining event deposits and final charges into one expense report is the best practice.
3. **Detailed Itemization:** To maintain transparency and enable accurate cost calculations per person, it is imperative to provide comprehensive itemizations for all event-related expenses. This includes categorizing costs, specifying the nature of each expense, and supplying receipts or supporting documentation for expenses exceeding \$75.

We highly encourage your participation in our Events and Entertainment instructor-led virtual course titled "Concur: Event and Expense Reimbursements." This valuable resource can be accessed through UC Learning. The next session is scheduled for Thursday, October 12th, from 9:00 AM to 10:30 AM, and these courses are offered once a month. By following these guidelines and enhancing your understanding of Concur through our informative courses, you can streamline your event and entertainment expense management process.

REMINDER: Travel Under 24 Hours

Please be aware that requesting reimbursement for Meals & Incidentals (M&IE) during trips lasting less than 24 hours is only allowable when there is a lodging expense included or if you are attending a business meeting where food is purchased. When meals are purchased, the correct Travel Expense Type is "Entertainment Meals – Travel Status" where proper approval routing will ensue. Alternatively, you should change the Report Type to "Event Expenses & Other Reimbursements" to claim Business Meeting meals, if there are no other travel expenses involved. Additionally, it's important to note that local conferences are subject to the same guidelines mentioned above.
