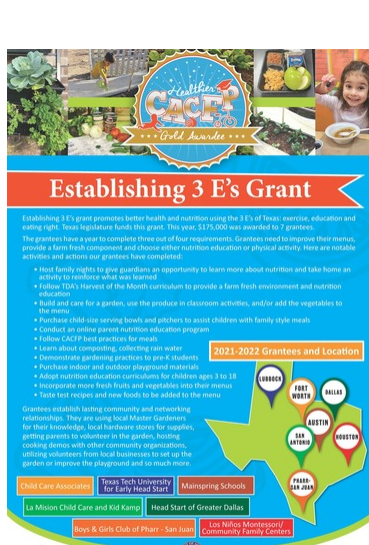
[Civil Rights Training Migrating to ICN](#)

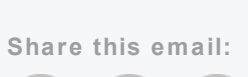
