The ongoing infant formula shortage due to supply chain issues, which worsened due to a major formula recall in February 2022, has left many Child and Adult Care Food Program (CACFP) operators concerned about access to formula and their options for safely feeding infants in their care. USDA has provided additional guidance to support CACFP operators dealing with this issue.

Policy Updates and Compliance Reminders

Flexibilities in the Keep Kids Fed Act for CACFP Operators

The Keep Kids Fed Act passed on June 27, 2022, will allow higher reimbursements for meals and waive area eligibility requirements for Tier II Day Care Home Providers.



New Guidance on the Collection of Racial/Ethnic Data

Based on guidance from USDA, TDA has developed Questions and Answers pertaining to the collection of racial and ethnic data at open Summer and At-risk sites now that visual observation is no longer an allowable option for collecting this data. These questions and answers will be included in the SFSP and CACFP FAQs located on SquareMeals.org and will eventually be included in the Program handbooks. The FAQs are located [here](#).

CACFP Program Year 2022-2023

The program year for CACFP is set to default to PY23. Please take note of the program year in which you are updating the application packet to ensure that the correct program year is being updated. When initially enrolling the PY23 application, all data from the last approved forms in PY22 will roll to the PY23 application.

Any subsequent updates made to PY22 once the PY23 application packet has been enrolled will need to be manually copied and entered into the PY23 application. Amendments made to site applications in PY22 will reflect in PY23. Therefore, please ensure that only one program year application is submitted at a time to avert any confusion as to which program year the sites should be processed.

Program Updates

TDA will conduct unannounced meal observations/site visits for PY22 SFSP administrative reviews. All TDA employees will identify themselves with a TDA/State of Texas issued identification.

Civil Rights Training Migrating to ICN

Effective May 15, 2022, the annual Civil Rights training that meets USDA Child Nutrition Program requirements as mandated in FNS Instruction 113-1 will be provided through the Institute of Child Nutrition (ICN) rather than TDA.
