2022 Texas Summer Mandate Notification and Waiver

Submit your intent for summer 2020 or submit a mandate waiver request in TX-UNPS by the January 31, 2022 deadline.



CEs must report verification results in the School Food Authority (SFA) Verification Collection Report, FNS-742 by February 1, 2022.

Onsite Monitoring Due February 1

CEs that operate more than one site are required to conduct onsite reviews. Click for more information.

Transitioning to the User Access Manager

TDA will begin a full transition to the User Access Manager for all entities and will retire the FND-101 form in Spring of 2022.

Policy Updates and Compliance Reminders

Low-Fat (1%) Flavored Milk: Congressional Flexibility Extended through February 18, 2022

Due to recent Congressional action, the flexibility allowing low-fat, flavored milk in the NSLP and SBP is extended through February 18, 2022. This flexibility was previously scheduled to end December 3. Schools do not need to request a meal pattern waiver from TDA to use this flexibility. Additional information on meal pattern flexibilities is available in the COVID-19 FAQ for School Year 2021-2022.
