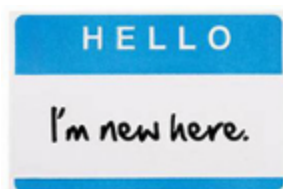
Lindsay Young, MD


