1 Month Away! UCPath June Release

Lived Name, Manage Job, Annual UCPath Upgrade

The [June Release projects](#) are scheduled to go-live in UCPath in **1 month**, on **June 20, 2023**.

Preparing for the Changes

1) Attend the June Release Topic Based Zoom

2) Approve all local UCPath transactions by Monday, June 12, EOD

All local UCPath transactions **must be approved by June 12, 2023 EOD** (end of day).

3) Keep a manual record of all UCPath transactions entered from June 1 – June 12

Transactors will need to plan to keep a **manual record** of all UCPath transactions entered between **June 1, 2023 to June 12, 2023** as part of UCPC's contingency plan, in case a system backup will need to be restored.

4) Be aware of the UCPath System Downtime

The UCPath system will be unavailable from **Friday, June 16 @ 3:00 pm – Monday, June 19 @ 9:00 pm** in order to implement the June Release projects. During the scheduled downtime, employees, managers, and transactors will not have access to the system.

Lived Name

The [Lived Name](#) project will update the Name field in the UCPATH system to show an employee's self-chosen name, in partnership with the [Gender Recognition and Lived Name Policy](#).

You may see an employee's legal name or receive a legal name from an external vendor. **Always** refer to employees by the name provided in the **Name** field in UCPATH. Remember to be mindful and familiarize yourself with the [Lived Name Terms and Definitions](#).

Transactors should search for employees using the EMPLID (Employee ID) to mitigate the risk around transaction validation. View the [Searching for Employees in UCPATH](#) visual graphic here.

Replace PayPath Phase 1: Manage Job Tile

Phase 1 of the [Replace PayPath](#) project will feature the new **Manage Job** tile, which will provide a modernized solution to accurately and reliably process job data information directly in UCPATH.



What's coming?

- The Manage Job tile will have improved Job Data display and new search and page display options to **improve data validation**

What will remain the same?

- Transactors will continue to use PayPath and Smart HR Templates
- The existing (classic) Job Data page that is in the HR Tasks tile will still be available

Who will be impacted?

- Early adopters from Central Offices will be able to transact and test the Manage Job tile functionality before all transactors can access the tile
- Transactors who currently have access to **PayPath** pages will see the Manage Job tile on the Workforce Administration page, but will be a **view-only** page.



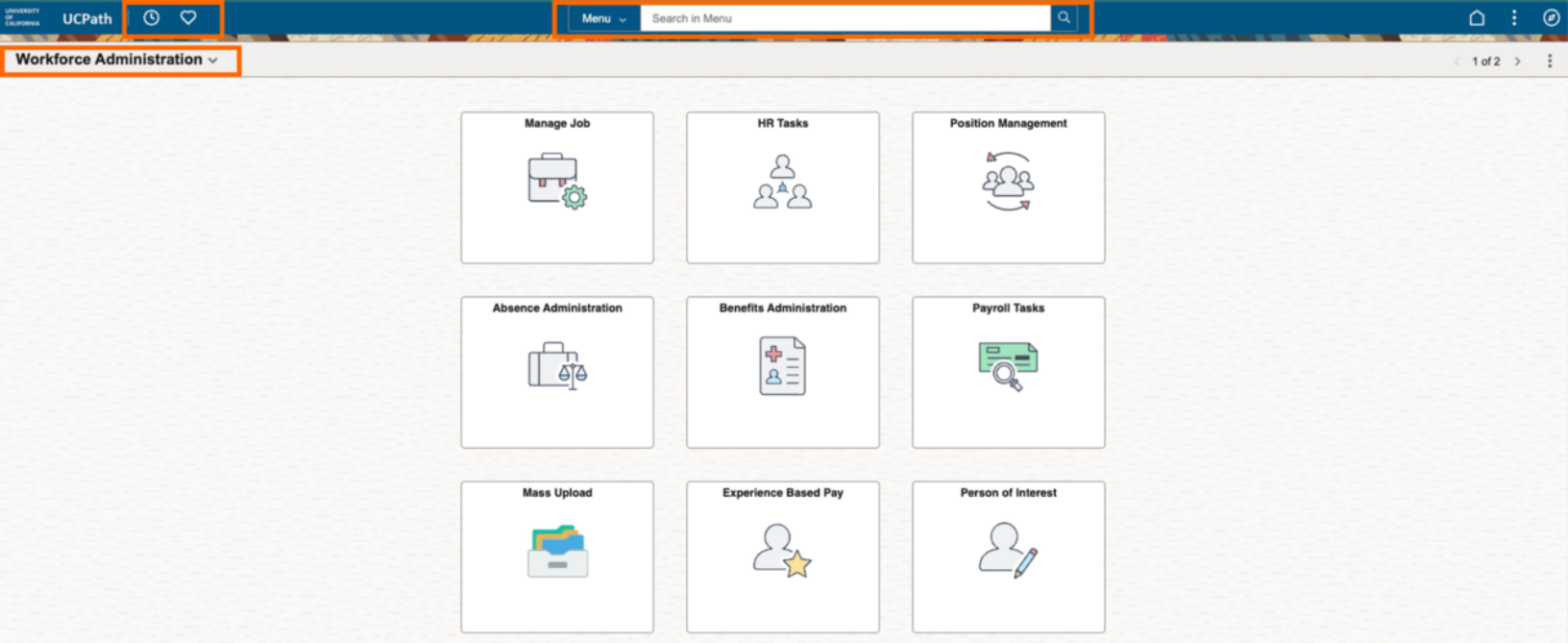

Annual UCPATH Upgrade

The [Annual UCPATH Upgrade](#) will deploy the latest PeopleSoft HCM software, PUM 44 and Tools 8.6, to the UCPATH system.

What's coming?

- A **new** Fluid interface with a color scheme that helps with visual accessibility
- A **new** Quick Access Bar with icons for Recently Visited pages, Favorites, and Global Search functionality
- A **new** Homepage selector to toggle between PeopleSoft Homepages (WFA and General Ledger)
- Label changes: the Transaction Status page will now be called **Smart HR Transaction Status** (Navigation: Main Menu > PeopleSoft Homepage > Workforce Administration > Smart HR Template > **Smart HR Transaction Status**)
