## **Our Response to COVID-19**

The novel coronavirus (COVID-19) has affected every aspect of life as we know it: schools are closed, people are losing work, and communities are being forced to distance. In these unprecedented times Gary Community Investments is doing everything we can to support Colorado children and families.

We are proud to partner with the <u>Colorado Department of Human Services (CDHS)</u>, the <u>Office of</u> <u>Early Childhood</u>, and the <u>Colorado Children's Campaign</u> to create the <u>Colorado Emergency</u> <u>Child Care Collaborative</u> in response to the need for COVID19 essential worker child care. Our partner <u>Nanno</u> developed a web-based platform which places the children of essential workers in licensed child care.

Thanks to the generous support of <u>Centura Health</u> and the <u>Buell Foundation</u>, and through CDHS' Michelle Barnes leadership, the Collaborative has been able to ensure child care for all essential workers completely free-of-charge through May 17. More than 6,000 children and 500 providers have signed up to participate, and <u>in the program's first week nearly 2,000 children were placed</u> in child care.

As Colorado continues to reel from COVID-19, Gary Community Investments is committed to seeking solutions that align with our mission, ensuring our states children and families have the support they need. Together, we will get through this.

# **Program Updates**



As a result of the Coronavirus (COVID-19) the federal and state tax filing deadline has been extended 90 days until July 15.

Although most free VITA tax sites around the state are now closed, including all the Tax Help Colorado sites, we want to ensure people are still able to file for free and claim the Earned Income Tax Credit.

We recognize the continued need for free, accessible and trustworthy tax filing services and cashback refunds provided from the EITC. There are still a number of free, online filing options available to taxpayers. Tax Help Colorado is focused on providing tax assistance through the **<u>Remote Drop</u>** <u>off pilot program</u> with Code for America.

We are encouraging taxpayers who expect to receive a refund to file as soon as possible to get cash back to help boost their income during this time of financial uncertainty. <u>Learn more about</u> <u>free online filing options</u>.
