



2) True or False? The General Assembly has 99 Senators and 33 Representatives.


3) True or False? TN Legislators will STOP the clock in the legislative chamber to meet a constitutional or statutory deadline.

Each year we review legislation that will impact the people of Tennessee specifically the poor and vulnerable. Thousands of bills are introduced in both Houses; only a few hundred will become law. All of them require careful analysis.



For example:

Tennessee NEEDS to make full use of federal Medicaid funding to stop hospital closures. Expanding Medicaid will infuse \$1.4 billion per year into TN. This will help SUSTAIN rural hospitals (six times less likely to close if TN expands Medicaid); COVER 300,000 uninsured Tennesseans; STIMULATE job growth—up to 15,000 jobs; LOWER health insurance premiums (up to 7% lower In 32 states that have already accepted the funding; PROVIDE greater access to addiction treatment center; All of this WITHOUT increasing taxes.

TOGETHER we present with one voice—to all branches of state government—the Church's position on THIS ISSUE and other public policies affecting the common good of all Tennessee citizens.
