IP Regimes May Delay a Timely Delivery of New COVID-19 Vaccines

As the Northern hemisphere entered winter, the threat of COVID-19 looms even greater than before. Cold air and more time spent indoors are likely to increase the transmission of COVID-19 drastically. Many individuals and governments are putting their hope into a breakthrough on a vaccine to keep them safe. But current intellectual property (IP) regimes may hinder and delay life-saving vaccines.

In Canada, the US and the EU, a patent can be valid up to 20 years after its filing, which means that the company which develops a COVID-19 vaccine can have a stranglehold on the production and pricing of the vaccine for two decades. This can have a significant impact on the ability for most populations to receive the vaccine. With over 1.2 Million deaths and 47 Million cases globally, any delay on the implementation of the vaccine will lead to disastrous loss of life.

IP Picks of the Week

A number of fees at the <u>Canadian Intellectual Property Office</u> (CIPO) have increased by 2% as of January 1, 2021 due to application of the <u>Service Fees Act</u>. As a result of this fee adjustment, the amounts shown in the <u>Tariff of Fees</u> in Schedule 2 of the <u>Patent Rules</u> may not be up-to-date. CIPO has published an <u>updated fee schedule here</u>.

The Office of the Chief Economist at the <u>United States Patent and Trademark Office</u> (USPTO) in collaboration with the USPTO's Patent Organization and <u>the Office of Policy and International Affairs</u> published a report on the increasing importance of Artificial Intelligence (AI) in invention.
