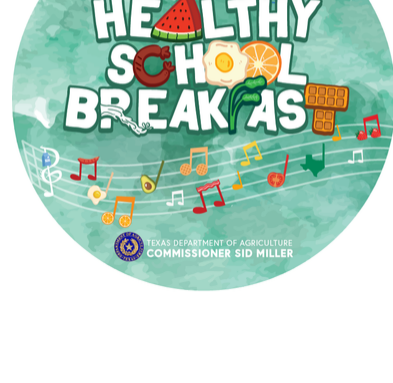

#### [TX-UNPS Default School Year 2023](#)

The default School Year for 2023 is set to View only mode until April 15, 2022. No changes to the 2023 application packet can be made until April 15, 2022. To modify the current 2022 application and submit any requested changes, please manually select the year 2021 – 2022.

#### [Security Form FND-101 to be removed from SquareMeals.org](#)

TDA has fully transitioned to the User Access Manager for all entities and plans to remove the FND-101 form on SquareMeals.org effective 5/1/2022.

#### [Community Eligibility Provision \(CEP\) Deadline – June 30, 2022](#)

The deadline to elect CEP for SY 2022-2023 is June 30th.

#### [Financial Report Deadline Extended to April 30th](#)

The Financial Report opened March 1st for fiscal year 2020-2021 and is now due by April 30th.

#### [Reminder: Pre-Kindergarten \(Pre-K\) Meal Eligibility](#)

Only pre-k students enrolled in a Head Start and Early Head Start programs qualify as eligible for free meals based on pre-k program enrollment.



#### [Universal Breakfast Program Waivers](#)

The Universal Breakfast Program Waiver application opens on March 15.

#### [RELEASE: 2022-2023 Income Eligibility Guidelines](#)

#### [RELEASE: Excess Net Cash Resources Plan](#)

A new Excess Net Cash Resources Plan form has been released. This form replaces the previous Plan for Reducing an Excessive Operating Fund Balance. TDA updated this form to clarify the funding source—"net cash resources"—and to align with USDA terminology. TDA plans to update the Administrator's Reference Manual (ARM) soon to align with this update.

#### [USDA Approves Four "Traditional" Summer Waivers](#)

USDA has approved TDA's requests to waive first week site visits for experienced SFSP sponsors, waive meal time restrictions for SFSP and SSO, allow closed enrolled SFSP and SSO sites to use area eligibility to establish site eligibility, and allow SFSP non-SFAs to operate Offer vs. Serve meal service. These waivers and flexibilities are traditionally available each summer for these programs. 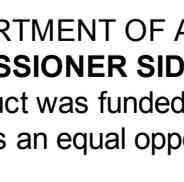
#### [Correction to the Administrator's Reference Manual \(ARM\)](#)

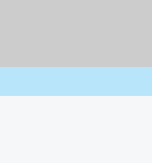
