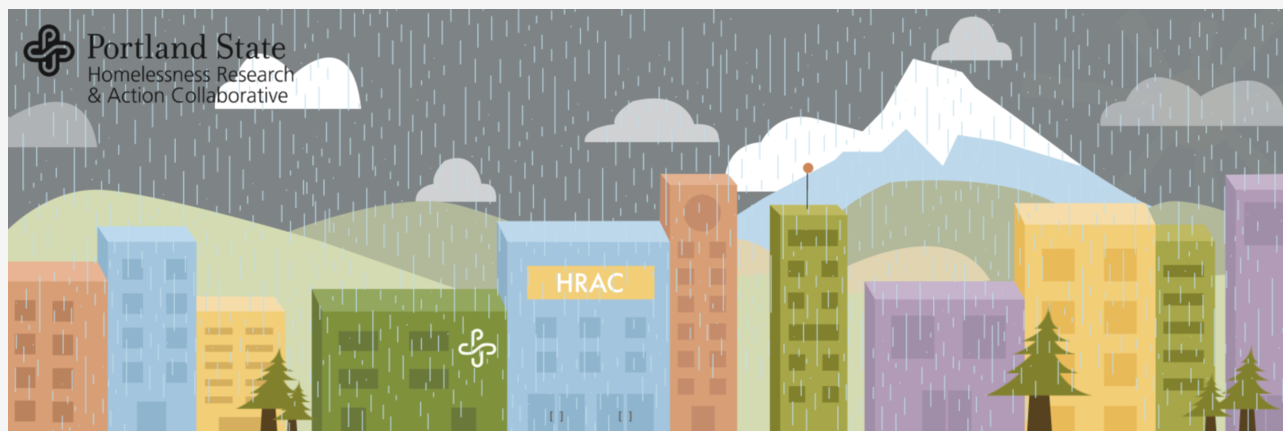

Cost of Oregon evictions could reach \$3.3 billion

A new report from Homelessness Research & Action Collaborative estimates that Oregon might be forced to spend between \$1 billion and \$3.3 billion to respond to mass evictions in the short term if additional eviction supports are not adopted during the pandemic.

Approximately 89,000 Oregon households owe back rent, according to the center's analysis of the Census Household Pulse survey of social and economic impacts of the coronavirus. A previous [study by Dr. Lisa K. Bates](#) shows that Black, Indigenous, and People of Color are disproportionately at risk of eviction during the pandemic.

To calculate the statewide cost of evictions, researchers used the Cost of Eviction Calculator developed by University of Arizona College of Law. The complete report includes recommendations including increased rental support to avoid mass evictions and the related downstream costs.

Portland Street Response

Non-police response to homelessness launches

Portland Street Response is now live in the Lents neighborhood. The program is a non-police response to assist people experiencing houselessness or a behavioral/mental health crisis.

Survey reveals needs of those living unsheltered

Director Marisa Zapata, the Joint Office of Homeless Services, Shannon Singleton, and Street Roots conducted a survey of people who are living unsheltered to better understand their needs as part of the Local Implementation Plan for the Metro Supportive Housing Services fund.

The results revealed profound racial disparities even in basic answers about who accesses shelter or who pitches tents. More than one in four people of color slept on the streets without a tent compared to only one in 10 people who are white. In addition, people of color were less likely to access shelters.

Overall, human connection including friends, family and even therapists and case managers ranked high among what could make people feel supported. For example, living someplace where friends and family could visit freely was one of the top three most frequently shared needs for housing.

Oregon cities are now required to develop housing production strategies that, for the first time in the US, include housing options for people experiencing homelessness, according to rules adopted by the Land Conservation and Development Commission under HB 2003.

Bills on Homelessness
