Safety & Health Training is a key part of any part of all workplace injury prevention programs.

Workers must have the skills and knowledge they need to do their work safely.

There are many OSHA standards that require the training of workers on specific hazards that they may face on the job.

Some standards require **annual training**, while others only require **initial** or **periodic training**.

The start of a new year is a great time to take a fresh look at OSHA's training requirements.

### TODAY'S BIGGEST PPE CHALLENGES: Key Insights from Dedicated Safety Managers

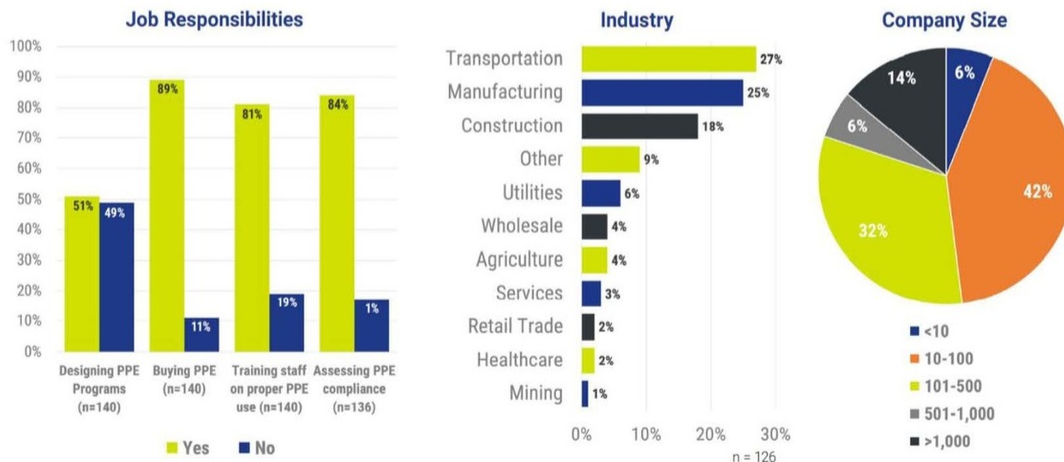

**BACKGROUND:** The J. J. Keller Center for Market Insights has taken the pulse of safety managers to learn more about the challenges they face in relation to personal protective equipment (PPE) — a key element in a company's overall safety program.

In this first annual survey, safety managers' commitment to protecting employees is unwavering, yet they experience real challenges. We hope that with the knowledge shared here, safety managers can understand they are not alone and gain insight into solutions employed by other companies.

**AUDIENCE:** Most of our respondents reported that their job titles included manager, director, or coordinator of safety/EH&S, and work in transportation, manufacturing or construction. A large majority are responsible for purchasing PPE for their employees, and work for smaller companies.



**SUMMARY:** Overwhelmingly, the most common PPE challenge facing our respondents is getting employees to wear their PPE in the first place. While the safety professionals that responded are clearly dedicated to employee safety, they expressed the importance and need for leadership support in order to do their jobs. When providing PPE, safety pros experienced challenges related to proper fit, environmental factors, and availability.
