Our team had the honor of participating in CASA Day at the Capitol, joining Georgia CASA and fellow affiliates from across the state to advocate for children in foster care at the state level. Standing alongside CASA programs from across Georgia was a powerful reminder that while our work happens locally, we are part of a strong statewide network working toward the same mission.

This year, Georgia CASA is championing an important initiative to strengthen support for high-volume affiliates serving large numbers of children. As part of this effort, a \$1 million funding request has been presented to help ensure that programs with the greatest caseload demands have the resources needed to recruit, train, and support volunteer advocates. This initiative reflects a proactive investment in children, ensuring communities can continue to meet growing needs.

We are grateful for the opportunity to meet with legislators, share the impact of CASA's work, and highlight the importance of continued support for children and families across Georgia.

One of her most memorable moments is on adoption day, as the judge spoke and a letter from the family was read aloud, she saw firsthand how every meeting, every report, and every hard conversation had led to something beautiful — a permanent, loving placement. It was a powerful reminder of why this work matters.

Tamila has been serving as a CASA volunteer for 2 years and 8 months, and during that time she has gone above and beyond for her families. As her supervisor Lisa shares:
