Webinar Series: Mercury and Sulfur Pollution in the Upper Great Lakes

Join the Northern Research Station's *Mercury Sulfur Initiative* for a two-part webinar series on the impacts of mercury and sulfur pollution in the Upper Great Lakes. Industrial activities have increased mercury and sulfate levels in the region, posing threats to ecosystems and human health. Topics will include the effects of sulfate on methylmercury production and its impact on wild rice, as well as new research and management solutions.

The Wisconsin Coastal
Management Program (WCMP) is
offering up to \$1.6 million in grants
aimed at enhancing, preserving,
protecting, and restoring natural
resources along Wisconsin's Great
Lakes coasts, which include nearly
1,000 miles of shoreline across
counties adjacent to Lakes
Superior and Michigan. These
grants support a wide range of
projects, from coastal wetland
protection and habitat restoration
to nonpoint source pollution
control and community planning.

National Coastal Resilience Fund (NCRF)



The NCRF restores and strengthens natural infrastructure to protect coastal communities and enhance habitats. It supports projects like marshes, wetlands, dunes, reefs, and more to reduce storm impacts and other natural events. Funded by NOAA and managed by NFWF, this grant program invests in nature-based solutions to increase resilience against climate change and flooding.

MW CASC Small Research Projects: Supporting New Collaborations



The Midwest Climate Adaptation Science Center (MW CASC) is offering a new funding opportunity! Small Research Projects aim to support activities that inspire or promote collaborative, decision-relevant research. Eligible activities include project scoping and data generation, relationship building, demonstration projects, as well as workshops, field visits, and related travel.

Priority will be given to projects led by or involving Tribal partners, or those addressing adaptation issues relevant to Tribal governments and communities. Funding is capped at \$15,000, with project timelines up to 12 months. Proposals are reviewed on a rolling basis.

The USDA Forest Service is accepting applications for the 2024 Great Lakes Restoration Initiative (GLRI) Grant Program to support reforestation, ecosystem restoration, and forest health in the Great Lakes Basin. Two grant opportunities are available: Cooperative Weed Management Areas (CWMA) and Forest Restoration (FR). Up to \$1 million is available for CWMA, and \$5.2 million for FR.


