FAFSA SIMPLIFICATION ACT



FAFSA is going through some changes for the 2024-2025 academic year. In the past, the FAFSA would open on October 1st. With the upcoming changes, the FAFSA is anticipated to be available for completion in mid-December. Please watch your email for more information over the next few months. You will receive a notification when the FAFSA is available.

The 1974 Family Educational Rights and Privacy Act (FERPA) protects the privacy of a student's educational record.

The Office of Financial Aid adheres to FERPA by protecting the student's right to privacy of their financial aid account.

To allow someone access to your financial and other Stetson University records:

1. Log into your My.Stetson portal at my.stetson.edu
2. Click on the "Authorized Users" tile to complete the form
3. This is a 2-part authentication, you complete one part, then the person(s) added will complete a second part after receiving a confirmation email

The Office of Financial Aid cannot speak with anyone about the student's financial aid unless they are granted permission by the student.



Q: How can I view my updated billing statement?

A: Follow these steps to view your most recent billing statement:

1. Login to your [MyStetson](#) portal.
2. Click on "Student Dashboard."
3. Click on "Student Account" on the left hand side of your screen.
4. Click on "Account Detail and Balance."
5. Select the current term (2023-2024).
6. Your current balance and an updated list of your financial aid will be listed at the bottom of the page.
