**Up this month is Council member Gabriela Orozco**



Gabriela “Gabby” Orozco sees her role on the Council as being a liaison and partner of Spanish-speaking families in her own community. Her experience, expertise, and knowledge, first and foremost, comes from being a parent of an adult son with autism and cognitive disability. The journey Gabriela has undertaken with her son and the families she has served helps her address different barriers within Arizona’s state systems. Her experience includes creating and collaborating with families in working in the public school system, managing prior HCBS companies and, now, owning and operating a company with her husband, Jose. The company Gabriela and Jose opened in 2014 is called Ideal Care LLC. It was founded with the mindset of providing appropriate and dynamic Home and Community-Based Services (HCBS), with an eye toward meeting the needs of families who often face unique challenges accessing the supports or services they or their children need.

Beyond operating Ideal Care, Gabby’s passions include helping and supporting Grupo de Apoyo para Niños Especiales, also known as “GANE”. It is a support group for Spanish-speaking families with children and adults with all kinds of disabilities. Gabriela took over as president of the group in 2006. GANE meetings are held at Ideal Care’s offices and typically around 45 people show up each week to listen to a presenter from the community.

Gabriela joined the Council because she believes in the mission and what it stands for. She says, “I have seen firsthand how they (Council members) are passionate about the community they serve, and this aligns perfectly with my own core beliefs.” The former ADDPC director, Erica McFadden, came to a GANE meeting along with another staff member and met Gabriela and her family, and through some persistence finally got her to join the Council.

**Spread the word. Keep your community covered. AHCCCS and KidsCare have returned to regular renewals.**

Regular Medicaid Renewals began April 1, 2023, and the Arizona Health Care Cost Containment System (AHCCCS) is required to resume the regular renewal process and disenroll ineligible individuals from AHCCCS and KidsCare. Over the course of 12 months, AHCCCS will complete a full eligibility renewal for all 2.5 million enrolled members, following a careful plan designed to make sure that no eligible members are wrongly disenrolled, and that anyone who no longer qualifies for Medicaid is referred to other health care insurance options. The return to regular renewal processes will be the first time in three years that Medicaid and Arizona's Children's Health Insurance Program (CHIP) members who no longer qualify for Medicaid will be disenrolled. Members will be notified of their eligibility renewal prior to their month of renewal.

**What AHCCCS Members Can Do To Prepare for Renewal:**

- The most important thing AHCCCS members can do right now is **update their contact information in Health-e-Arizona Plus** ([www.healtharizonaplus.gov](http://www.healtharizonaplus.gov)). To update contact information, log in to [www.healtharizonaplus.gov](http://www.healtharizonaplus.gov) or call Health-e-Arizona Plus at 1-855-432-7587, Monday through Friday 7:00 AM - 6:00 PM.
- **Sign up for text/email notification alerts from AHCCCS and respond to all AHCCCS requests for information in a timely manner.** To sign up for text/email alerts of AHCCCS notifications, log in to [www.healtharizonaplus.gov](http://www.healtharizonaplus.gov), go to "Message Center" on the toolbar, and click on "Manage My Alerts and Letters." Look for a letter from AHCCCS and respond if needed.



**More than words: Taking Arizona's Employment First philosophy from theory to practice**

State Sen. Steve Kaiser, R-Phoenix, recently presented a [resolution](#) to his Senate colleagues that might be one of the most important pieces of business the Legislature attends to this session. It didn't assert the need for a balanced

budget or a secure border or call for passage of a bill that would divide supporters and opponents along partisan lines. What it did was affirm that every person, regardless of ability, should have the right to pursue meaningful work that is essential so that individuals with disabilities in Arizona can thrive.

The first few lines of Sen. Kaiser's resolution articulate a goal that should be obvious to anyone and yet remains frustratingly elusive. "Every Arizonan should have the opportunity to participate in the workforce, including those who have disabilities."

The resolution amplifies the goals of an Executive Order signed in 2017 that designates Arizona as an "Employment First" state.

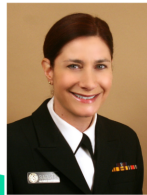

- Explain motive and support plans for employment and transition to self-sufficiency

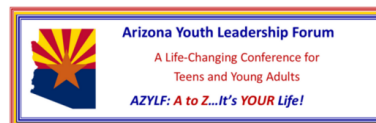

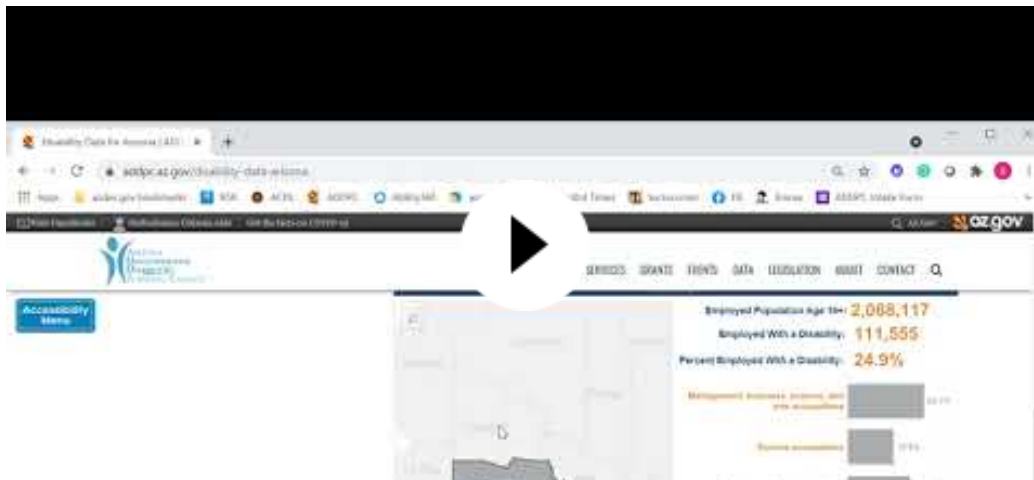
