PADUA 2.3 Release Coming Soon

The Project and Award Data Update Application (PADUA) will have new features released this month. Release 2.3 will include updates to Award Personnel and request updates to sponsored projects (with final approval through SPF). It will also allow for the ability to update General Project start dates and update the project status (closed/open). Recharge projects and tasks requests will now have workflow to CP&A. These updates are scheduled to be released **March 17**, **2023**.


Oracle Project Cost Adjustment Workflow Notification Updates Coming 03/17/2023

In August 2022, the Oracle Workflow Notifications were updated to include more detailed information to allow you to take advantage of the ability to approve pending transactions via email. We're happy to announce that Project Cost Adjustments (Cost Transfers) has also been updated. This is an additional enhancement from the Oracle updates to Project Cost Notifications in late December 2022. Upcoming release date of March 17, 2023.

Oracle Journal Categories

In an effort to streamline the journal entry process, we analyzed the number of unused categories and have reduced the dropdown list from 124 to 39 values.

Separation of Duties Between Procurement Cardholder and Reviewer

This is a reminder that the duties of individuals who are authorized to make purchases with a Procurement Card and Reviewers shall be separated to ensure that the items ordered were received and that the purchases are appropriate. A Reviewer (Financial Unit Approver) other than the person placing an order shall certify that the items ordered were received. Financial Unit Approvers shall perform an administrative review of purchase documents to verify that the expenditures listed within the Concur Expense Report are supported by the required documentation and a detailed business purpose.

Update! Budget & Financial Management Reports Panorama Split

The Campus Budget Office has split the previously named Budget and Financial Management Reports Panorama into two separate dashboards as follows:

Financial Resource Management Dashboard

This dashboard delivers a full suite of financial management reports intended to support campus business officers. They are designed to support internal financial management of the university finances, and as such use Managerial Reporting hierarchies.

- Net Operating Results and Fund Balance (NOR).
- Updated! Financial Deficit Report Operating Funds.
- Updated! Financial Deficit Report Sponsored Projects.
- Updated! Fund Summary.
- GL Project Summary by Fin Unit.

- Managerial Reporting Account Hierarchy.
- Managerial Reporting Fund Hierarchy.

Planning and Budgeting Dashboard

This dashboard delivers an initial suite of planning and budgeting reports intended to support campus business officers. They are designed to support internal variance analysis against the university budget plans captured in the Oracle Planning and Budgeting tool, and as such use Managerial Reporting hierarchies.

GL Project Balances

The following enhancements have been made to the GL Project Balances report:

- New Project Organization prompt
- New Project Manager prompt
- Report excludes rows where all measures (e.g. beginning balances, YTD resources, YTD expenses, etc.) are \$0

UCPath-PPM-GL Salary Reconciliation

The UCPath-PPM-GL Salary Reconciliation report has been modified to account for Pay for Family Care and Bonding (PFCB). PFCB salary is charged as normal salary in both the Labor Ledger (UCPath) and in Oracle, but is subsequently refunded to the Project in Oracle only. This was creating artificial discrepancies on the Salary Reconciliation report.

The PFCB salary amount from UCPath is now broken out into a separate column and is not included in the Variance calculation. In cases where the refund occurred in a different month from the original salary, you will see a variance in the month of the salary and the opposite variance in the month of the refund.
