[Four Steps to Food Safety: Clean, Separate, Cook and Chill](#)

Separate: Don't cross-contaminate. Prevent bacteria from spreading by following these tips

- Separate raw meat, poultry, seafood, and eggs away from other foods. This applies when transporting, storing, and cooking food
- Use separate cutting boards, utensils and plates for raw meat, poultry, and seafood

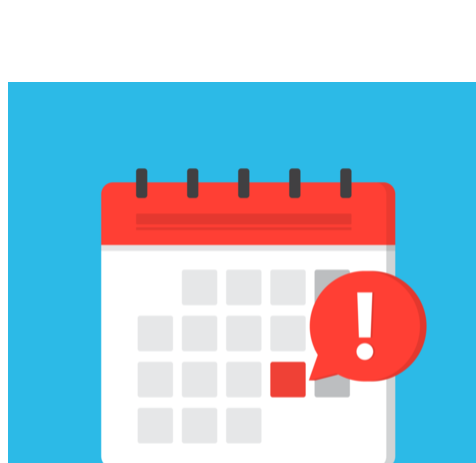

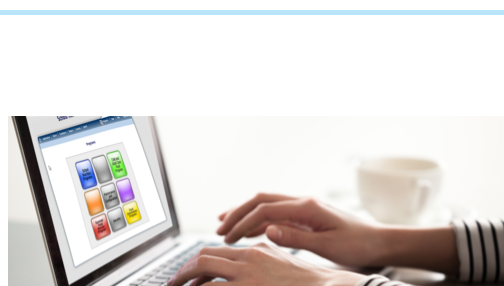
TDA has fully transitioned to the User Access Manager for all entities and plans to remove the FND-101 form on SquareMeals.org effective 5/1/2022.



Policy Updates and Compliance Reminders

[Administrative Reviews Notification](#)

Effective June 1, 2022, TDA F&N will no longer consider Administrative Reviews (ARs) due for review based on the program cycle and program requirements for cancellation/postponement due to COVID impacts. [USDA Approves Four Traditional Summer Waivers](#)

USDA has approved TDA's requests to waive first week site visits for experienced SFSP sponsors, waive meal time restrictions for SFSP and SSO, allow closed-enrolled SFSP and SSO sites to use area eligibility to establish site eligibility, and allow SFSP non-SFAs to operate Offer for vs. Serve meal service. These waivers and flexibilities are traditionally available each year for these programs. 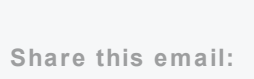
