Peruse the headlines, and it seems the Diversity, Equity, and Inclusion movement has moved on—at least for now.

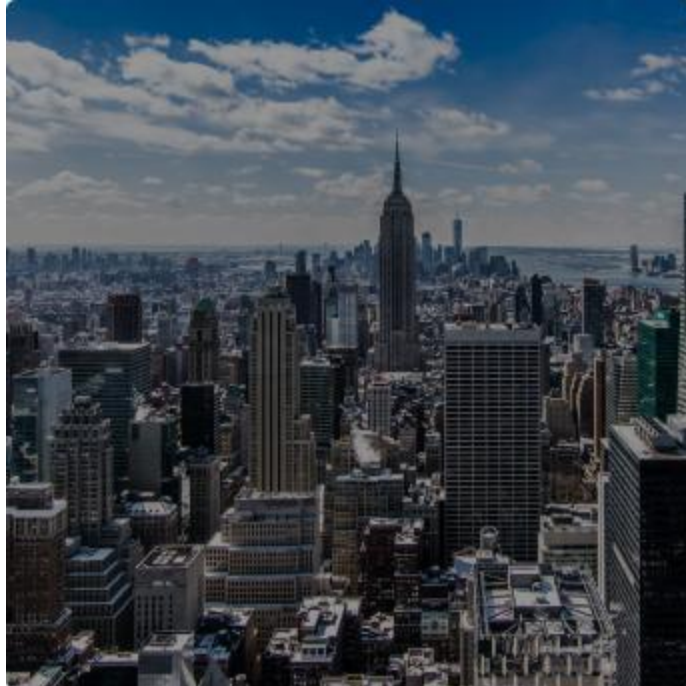
