Mid-Term Grades and Dropping a Course

All students who received a mid-term grade below "C" are encouraged to visit with a UCFY counselor to discuss options for improved performance in the remaining weeks in the fall semester. It may be wise to consider dropping a course, if necessary. The deadline to drop classes is Friday, November 4, 2016 at 4:30 p.m. All UCFY students must consult with one of our counselors to drop a class.

Academic Tracking – Advising Important Dates

University College plays an important role in advising and guiding your LSU student through the start of a successful undergraduate career. Fall classes are in full force, yet it is already time for advising and planning for the spring courses.

LSU's Comprehensive Academic Tracking System (CATS) monitors students' progress toward degrees and CATS has an important October review of your student. Students who are not enrolled in critical CATS course requirements for Fall 2016 have received an email to alert them of any deficiency, and a meeting with a University College academic counselor is required to discuss a resolution to the tracking issue.

Students may review CATS in the Recommended Paths tabloid received at orientation, and degree audits can be found at http://MyLSU/Student Services/Degree Audits. A spring semester registration hold will be in place until the CATS conversation is held.

Students in UCFY with declared majors are expected to be familiar with these three things:

- 1. CATS tracking requirements and the 8-semster degree plan
- 2. Admission requirements to the senior college
- 3. How to read a degree audit

Reminder: University College is sponsoring TOPS eligibility presentations on October 25, 2016. Attendance is monitored and expected. Each meeting lasts 25 minutes. BRING LSU ID to enter. Location: LSU Student Union - Atchafalaya Room



Tiger's Den Is Back!


