## RELEASE: SFSP and SSO Rural Non-Congregate Service Regulations

USDA issued an Interim Final Rule at the end of December outlining the new regulations allowing SFSP and SSO operators in rural areas to provide non-congregate meal service to participants. Stay tuned to the newsletters and SquareMeals.org for more information on how to apply!

### RELEASE: NEW Duplicative Services FAQs

TDA has released a set of FAQs related to duplicative costs. A duplicative cost is an unallowable expense that results from a CE paying for the same service under multiple contracts using federal funding.

## Action Required: Sponsors at Unaffiliated At-Risk Sites

Beginning February 16 and no later than June 30, all sponsors of unaffiliated At-Risk Sites are required to submit a questionnaire/attestation form confirming that they are conducting all required oversight functions at their unaffiliated sites and that those sites are responsible for the oversight of a complete afterschool enrichment program.

## <u>Unanticipated School Closure Notification</u> <u>Forms and Guidance</u>

If a school closes due to an unanticipated event and wants to serve students during the closure, the school district must choose an appropriate Program to operate (SFSP, SSO, or CACFP At-Risk) and notify TDA via the newly released Unanticipated School Closure Notification Form.

#### Reminder for TX-UNPS and WBSCM Entities

Contracting entities can now assign two User Access Managers/User Admins (UAM/UA) to manage security in TX-UNPS/WBSCM systems.



## VCA Management Plan Reminder

There has been an important update regarding the Summer Food Service Program (SFSP)

Management Plan. The SFSP Management Plan is now integrated into the TXUNPS platform.

#### Who Needs to Complete the Management
