#### >> Public Safety Committee Update

##### Street Lights

There has been some discussion on neighborhood list serves about what to do about street lights that are out or not working properly. If you have a problem on your street, you can either use the website by [clicking here](#), or you can call 311 (general non-emergency County number for service requests). Let's make sure the nights are bright and safe during this darkest part of the year.

##### Crime Reports

On December 8 a strong-arm robbery occurred in the area of Faulkner Place and Drumm Avenue at approximately 11:00 pm. The suspects assaulted the adult male victim and took his property.

This crime appears to be an isolated incident, but to avoid becoming a victim:

- notice your surroundings when walking at night:
- avoid poorly lit areas
- walk with a purpose
- if you fear you are being followed, head for a well-lit or populated area, call attention to yourself, and phone for help.

If you are a victim of a robbery, call 911 immediately and file a police report. Additionally, police advise not to immediately cancel credit/debit cards because they can be used to locate and possibly apprehend the thief.

#### >> Traffic Safety Committee Update

##### Farragut/McComas

KHCA is reaching out to residents who live along the stretch of McComas Avenue and Farragut Avenue between St. Paul Street. That area is experiencing dangerous traffic during the morning rush hour. Drivers seem to be gaming the system to avoid a 'Do Not Enter' sign posted on St. Paul and McComas southbound. About 10 residents now support resolving this issue. They feel endangered by the morning traffic, and are concerned about the noise and fumes.

A petition has been drafted in order to mobilize residents and demonstrate to Montgomery County Department of Transportation and the Kensington Town Government that residents are serious about this issue. #### >> Montgomery County Civic Federation

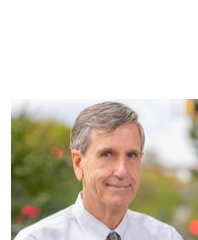
