COVID-19 first appeared in December 2019. By March 2020, the virus was spreading around the world with increasing speed, [leading the World Health Organization to declare a global pandemic.](#)<sup>[i]</sup> The spread of the virus has had profound impacts on nations around the world, and researchers have mobilized resources at an unprecedented scale to address COVID-19.

Canada has had a comprehensive response to this pandemic. Taking into account total expenses associated with measures announced as of September 1, 2020, [the Government of Canada is expected to spend an estimated \\$225.9 billion in COVID response measures.](#)<sup>[ii]</sup> This includes spending related to Federal fiscal stimulus and other initiatives to support Canadian individuals and businesses.
