### **Uncleared (Concur) Credit Memos in OFC – New Report!**

A new report has been released in the Business Activity Hub (BAH) that displays outstanding Credit Memos from Oracle Financials Cloud (OFC), created via Concur Expense Reports with a net amount owed by the employee as a result of Personal/Non-Reimbursable Card Charges, Cash Advance Returns or Travel Card Per Diem Offset.

The report is accessible through two panoramas (1) the Department Exceptions Panorama, and (2) the Procure-to-Pay Panorama in the BAH, under Budget & Finance. Filters for employee, invoice number (i.e. Credit Memo number) and Financial Unit are available. Information about this new report is available through [Blink](#).

### **Concur User Interface (UI) Updates are now LIVE!**

Starting October 2nd, Concur has implemented a new default User Interface (UI). While this is now the standard look, you can still access the old UI by clicking the "New Theme" button in the top right corner of the homepage.

Please note that the old theme will be phased out by January 2024. To make a smooth transition, we recommend getting acquainted with the new theme. One significant change is that the Request, Expense, and Approval modules are now only accessible via the "Home" dropdown in the top left corner of the Concur homepage.

**Update to Law AB 1887**

As of September 13, 2023, Governor Gavin Newsom signed [SB 447](#) which ends the ban on state funded travel effective immediately. Former **Law AB 1887** which “prohibited state-funded travel to states that had passed a law after June 26, 2015 that (1) authorized discrimination based on sexual orientation, gender identity, and gender expression, or (2) voided or repealed existing state or local protections against such discrimination” is no longer in effect. This update should not impact your upcoming trips, but if you have any questions please contact your fund manager.

### Split amounts using Currency

When splitting costs in Manage Project Costs (for Splits or Split & Transfers), be sure to only enter currency amounts (2 digits past the decimal point) IF the unit of measure is Currency. Otherwise, rounding issues can occur that will not net to zero.
